

This particular item is an excellent overview of case management practice for beginning and experienced case managers alike. Every aspect of case management practice from definitions to professional boundary issues and ethics to listening skills is covered. While this volume handles each topic in depth, the writing is straight-forward and no-nonsense. This combination makes the information necessary for a thorough discussion on the topic very accessible even to the novice. Chapter 1 entitled "Ethics and Other Professional Responsibilities for Human Services Workers" provides a strong base for the subsequent discussions which follow. Chapters 6 and &7, "Seeing Yourself as a Separate Person" and "Clarifying Who Owns the Problem", flush out issues which need to be addressed in today's expanding market of paraprofessional services. This book is a good resource for the shelves of those already working as case managers and a great text for students

preparing themselves for work in the field of human services.

This is a text you will use day in a day out--never give it away, you will be sorry.I love the text's format. The ethics exercises, hypothetical client needs exercises, practice exercises for every chapter, and forms in the appendix are all fantastic/brilliant.This is a must need tool for case management.

As a former clinician I find the book realistic and one that I wish I had used when I obtained my MSW. There are some shorter books that are very good but none with the depth and breadth of this particular work. I use this book for half of a semester in conjunction with another text that covers psychotropic medication so it has to have some staying power. I used the previous edition and continue with this edition which has improved teaching aides. The PowerPoints are actually usable as is the test bank and that is most certainly not always the case. As a matter of fact most of the PowerPoint resources that I have used that came with other text books were literally unusable.I use this book at Columbia College where I teach a Case Management Class in our Human Services program and it is perhaps the most realistic and down to earth text I use. One quirk, not a flaw but something to be aware of, is that there has been no attempt to make the chapters the same length. That is a normal practice for most test books so you would cover one chapter a week - or something like that. But, the chapters in this book run from ones that are fairly lengthy to ones that are very short.

Was missing pages from the practice forms in the back. But it was used and significantly cheaper so I came complain. My teacher demanded we get the newest edition but I found this book, aside from some politically correct corrections and a few changes in the practice questions to work just fine.
